Call to Order

The November 5, 2018 Negotiating Committee meeting was called to order at 12:06 p.m. by Chairman David Englebert at the Door County Government Center.

Roll Call (Establish a Quorum)

Members present: David Englebert, Joel Gunnlaugsson, Kathy Schultz, Laura Vlies Wotachek, and Megan Lundahl.

Others present: County Board Chairman David Lienau, County Board Vice Chairman Ken Fisher, Administrator Ken Pabich, Corporation Counsel Grant Thomas, Human Resources Director Kelly Hendee, Sheriff Steve Delarwelle, ES Director Aaron LeClair, Chief Deputy Pat McCarty, and County Clerk Jill Lau.

Approve Minutes of the October 2, 2018 Negotiating Committee Meeting

Motion by Vlies Wotachek, seconded by Gunnlaugsson to approve the minutes of the October 2, 2018 Negotiating Committee Meeting. Motion carried by unanimous voice vote.

Initial Bargaining Proposals of the Door County Deputy Sheriffs' Association *and* Door County Emergency Services IAFF Local 4982 (collectively 'public safety employees')

CC Thomas and Administrator Pabich reviewed the information included in the meeting packet. The initial proposals were received. The DC Deputy Sheriffs' Association will meet with county staff again this week.

The initial proposals for each association were reviewed.

The Deputy Sheriff's Association proposes a 4 year contract with a 2.25% across the board increase. Increase shift differential to 2.25%. Proposing adding language regarding instructors to receive additional hourly pay when instructing. Proposing to amend the agreement for paid sick leave to increase from 50% to 75%. Proposing to increase accumulated compensatory time from 80 hours to 96 hours. Continue the K9 MOU with modifications. Delete the seniority calculation language. Amend the MOU regarding Eligibility List with the change to make the required ride-a-long or job shadowing be a straight 40 hours which can be done at any time. Remove language regarding the one week limitation for taking ½ day vacations. The County proposed a 1 year, status-quo contract, with a 1% increase.

The Emergency Services IAFF proposes a multi-year contract. Proposes language changes related to shifts. Proposes a 4% wage increase for all years of the contract.

Convene in closed session for the purpose of developing negotiating strategies to be used in collective bargaining under Ch. 111, Wis. Stats. with public safety employees, as bargaining reasons require a closed session pursuant to § 19.85(I)(e) Wis. Stats.

Motion by Gunnlaugsson, seconded by Vlies Wotachek to convene in closed session.

Motion carried on a roll call vote, with all members present voting 'yes'. Time: 12:25 p.m.

WHEREAS, The Collective Bargaining Agreement between Door County and the Door County Deputy Sheriffs' Association expired on December 31, 2018; and
