The Door County Board of Supervisors, pursuant to Section 59.69(5)(e)., Wisconsin Statutes, does hereby ordain an amendment to the detailed zoning map of the Town of Forestville to change the zoning district classification of the following tracts from Wetland (W) to Rural Residential (RR):

**Parcel 1**

A tract of land in Lot 17 of the unrecorded Sleepy Hollow Subdivision. A subdivision located in the NE ¼ of the NE ¼ of Section 30, T 26 N, R 25 E, Town of Forestville, Door County, Wisconsin, more particularly described as follows: Commencing at the Northwest corner of Section 29, thence S 88°49'21" W a distance of 1227.82 feet, thence S 41°10'12" E a distance of 394.76 feet. Thence S 25°39'04" E a distance of 486.51 feet, thence N 59°52'58" E a distance of 14.63 feet to the point of beginning, thence continuing N 59°52'58" E a distance of 215.46 feet to the westerly side of Sleepy Hollow Drive, thence Southeasterly along the arc of a 216.00 foot radius for a length of 36.84 feet with a chord bearing of S 25°13'31" E for a distance of 36.79 feet, thence S 30°07'02" E a distance of 223.34 feet, thence S 59°52'58" W a distance of 229.93 feet, thence N 07°41'59" W a distance of 12.75 feet, thence N 26°19'19" E a distance of 39.43 feet, thence N 34°38'32" W a distance of 24.42 feet, thence N 32°20'59" W a distance of 25.82 feet, thence N 07°54'30" E a distance of 85.33 feet, thence N 06°09'53" W a distance of 42.42 feet, thence S 53°42'43" W a distance of 85.09 feet, thence N 76°14'54" W a distance of 5.85 feet, thence N 22°46'43" W a distance of 29.04 feet, thence N 32°23'26" W a distance of 46.63 feet to the point of beginning. Said tract containing 1.12 acres of land more or less.
