2 reviewed Chapter 31.02 Door County Code; and

4 **WHEREAS**, Chapter 31.02(1)(a) currently reads: (1) "It
5 shall be unlawful for any person in the County of Door to:
6 (a) To unnecessarily or willfully discharge any firearm or
7 explosive, or in any other manner create any noise or
8 disturbance, making any threats of violence or resort to
9 violence or to flourish any weapon intending to disturb the
10 peace and good order or frighten any of the inhabitants of
11 Door County."

13 **WHEREAS**, The Law Enforcement Committee has
14 recommended amending Chapter 31.02(1)(a) Door County
15 Code to reflect the language of the Wisconsin Statutes; and

17 **NOW, THEREFORE, BE IT ORDAINED BY THE**
18 **COUNTY BOARD THAT**, Chapter 31.02(1)(a) Door County
19 Code is hereby amended to read as follows: (1) "It shall be
20 unlawful for any person in the County of Door to: (a) To
21 unnecessarily or willfully discharge any firearm or explosive,
22 or in any other manner create any noise or disturbance,
23 make any threats of violence or resort to violence or to
24 flourish any weapon tending to disturb the peace and good
25 order or frighten any of the inhabitants of Door County."

27 **BE IT FURTHER ORDAINED BY THE COUNTY**
28 **BOARD THAT**, To the extent that the provisions are not in
29 conflict herewith, Chapter 31.02 Door County Code shall
30 remain in full force and effect.

32 **BE IT FURTHER ORDAINED BY THE COUNTY**
33 **BOARD THAT** This Ordinance shall be in full force and
34 effect the day following publication.
