14 to the intersection with the centerline of S.T.H. "42-57", thence N

16 thence S 59°37'28" E 250.00 feet, thence S 30°22'32" W 86.12
17 feet, thence S 81°12'33" E 107.57 feet, thence S 30°27'48" W
18 406.82 feet, thence West 125.85 feet, thence S 00°23'00" E
19 200.00 feet to the point of real beginning


