4 The following is an addition to Chapter 34.002 of the Door County Code entitled "Speed Limits":

7 The Town Board of the Town of Forestville has requested a 35-Mile per Hour Speed Zone on County Trunk Highway "H":

10 CTH "H" Starting at the intersection of State Highway 42 thence westerly to Mill Road.

13 The Door County Board of Supervisors does hereby repeal the established forty-mile per hour speed limit on County Trunk Highway H from State Highway 42 to Mill Road:

16 The Door County Board of Supervisors does hereby ordain to create a thirty five-mile per hour speed zone on County Trunk Highway H from State Highway 42 to Mill Road.

19 The Door County Board of Supervisors does hereby ordain to authorize the Door County Highway Committee to erect such speed zone signs as consistent with the Wisconsin State manual of Traffic Control.
