1 The Door County Board of Supervisors, pursuant to Section
 2 59.69(5)(e)., Wisconsin Statutes, does hereby ordain an
 3 amendment Section 4.08(5)(l) of the text of the Door County
 4 Zoning Ordinance to read as follows:

5
 6 (l) One accessory structure shall be permitted for
 7 each manufactured home site and shall not
 8 exceed 576 square feet in floor area. When
 9 the homeowner owns the site, an accessory
 10 structure garage may be attached to the home
 11 but no other accessory building shall then be
 12 allowed on the site. (Underlined to be added.)

 14 Pursuant to Section 59.69(5)(e)6., Wisconsin Statutes, this
 15 ordinance shall take effect on the 41st day after the date of
 16 adoption unless 1) a majority of the zoned towns have filed
 17 certified copies of resolutions disapproving of this amendment
 18 with the county clerk prior thereto in which case this
 19 amendment shall be void; or 2) unless within a shorter time a
 20 majority of the zoned towns have filed certified copies of
 21 resolutions approving of this amendment, where upon it shall
 22 come into full effect.
