 8 Renumber existing Section 4.08(8)(a) paragraph 2 as (a)
 9 Definition, to read, "Any room within a multiple
 10 occupancy development (MOD) occupancy unit that is
 11 not a kitchen, living room, dining room, bathroom, or
 12 utility room shall be counted as a bedroom. If the site
 13 building plan for an occupancy unit depicts no bedrooms,
 14 the occupancy unit shall be considered to contain one
 15 bedroom. (Underlined word to be added.)
