7 Private roads serving 4 lots or less or land-only condominiums
8 with 4 or fewer building sites shall not have less than 30 feet of
9 right-of-way, and 16 feet of travel surface width. (Underline words

12 Amend Section 5.02(3) to read as follows:

14 Private roads within a major land division or land-only
15 condominium with 5 or more building sites shall meet the following
16 standards. (Underline words to be added) (Subsequent standards
17 relate to road design.)
