**THE DOOR COUNTY BOARD OF SUPERVISORS DOES
HEREBY ORDAIN AS FOLLOWS:**

- 7 reference) shall be known as, referred to, and may be cited as the
- 8 "Unlawfully Obtain or Possess Prescription Drug or Controlled
- 9 Substance" and is hereinafter referred to as this Ordinance.

- 11 This Ordinance shall be designated as Chapter 31.43 of the Door
- 12 County Code.
