1 The following is an addition to Chapter 34.002 of the Door County
2 Code entitled "Speed Limits":

4 The Highway Committee has requested a 35-Mile per Hour Speed
5 Zone on County Trunk Highway "C":

7 County Highway "C" starting at the intersection of
8 North Duluth Avenue thence west 1/4 mile.

10 The Door County Board of Supervisors does hereby repeal the
11 established forty-five mile per hour speed limit on County Trunk
12 Highway "C" from North Duluth Avenue thence west 1/4 mile.

14 The Door County Board of Supervisors does hereby ordain to create
15 a thirty five-mile per hour speed zone on County Trunk Highway "C"
16 from North Duluth Avenue thence west 1/4 mile.

18 The Door County Board of Supervisors does hereby ordain to
19 authorize the Door County Highway Committee to erect such speed
20 zone signs as consistent with the Wisconsin State manual of Traffic
21 Control.

23 This ordinance shall be effective upon its adoption and publication
24 by the Door County Board of Supervisors as provided by law.
