1 The Door County Board of Supervisors, pursuant to Section 59.69(5)(e),  
2 Wisconsin Statutes, does hereby ordain an amendment to the detailed zoning  
3 map of the Town of Washington to change the zoning district classification  
4 of the following tract from Countryside (CS) to Estate (ES):

6 The West On-half (W ½ ) of Lot One (1), Section Twenty  
7 (20), Township Thirty-four (34) North, Range Thirty (30)  
8 East, excepting therefrom that portion of Government Lot  
9 Two, said section, town and range lying within the limits of  
10 the following described property: A tract of land located  
11 partly in Government Lot 1 and partly in Government Lot 2 of  
12 Section 20, Township 34 North, Range 30 East, Town of  
13 Washington and described as follows: Commencing at the  
14 SE corner of said Section 20, thence west along the section  
15 line 669.59 feet to the point of real beginning, thence  
16 continue west along said section line 700.75 feet, thence N  
17 00°58'50" E 981.40 feet, thence N 67°06'40" E 752.84  
18 feet, thence S 00°25'55" W 1274.10 feet to the point of  
19 beginning. (Tax Parcel No. 028-04-20343011H).

21 Pursuant to Section 59.69(5)(e)6., Wisconsin Statutes, this ordinance shall take  
22 effect on the 41<sup>st</sup> day after the date of adoption unless: 1) the Washington Town  
23 Board has filed a certified copy of a resolution disapproving of such amendment  
24 with the county clerk prior thereto in which case this amendment shall be void; or  
25 2) unless within a shorter time, the Washington Town Board has filed a certified  
26 copy of a resolution approving of this amendment with the county clerk,  
27 whereupon it shall then come into full effect.
