 14 disapproving of these amendments with the county clerk prior thereto in  
 15 which case this amendment shall be void; or 2) Unless within a shorter  
 16 time the Gibraltar Town Board has filed a certified copy of a resolution  
 17 approving of these amendments whereupon they shall then come into full  
 18 affect.
