1 The Door County Board of Supervisors, pursuant to Section
2 59.69(5)(e)., Wisconsin Statutes, does hereby ordain an
3 amendment to the detailed zoning map of the Town of Gibraltar to
4 change the zoning district classification of the following parcel from
5 Heartland-3.5 (HL3.5) to Single Family Residential-20,000 (SF20)
6 A tract of land in the Southeast one-quarter of the Southwest one-
7 quarter of Section 33, Township 31 North, Range 27 East, Town of
8 Gibraltar, Door County, Wisconsin and described as follows:

10 Commencing at the South one-quarter corner of said Section 33,
11 thence S 88°18'11" W along the section line 869.84 feet to the point
12 of real beginning, thence continue S 88°18'11" W along said
13 section line 456.48 feet to the southwest corner of said Southeast
14 one-quarter of the Southwest one-quarter of Section 33, thence N
15 01°41'22" W along the one-sixteenth line 826.58 feet, thence N
16 87°42'18" E 456.51 feet to an existing 1" iron pipe, thence S
17 01°41'22" E 831.34 feet to the point of real beginning.

18 Said tract contains 8.687 acres of land.

20 Pursuant to Section 59.69(5)(e)6., Wisconsin Statutes, this
21 ordinance shall take effect of the 41st day after the date of adoption
22 unless 1) the Gibraltar town board has filed a certified copy of a
23 resolution disapproving of this amendment with the county clerk
24 prior thereto, in which case this amendment shall be void; or 2)
25 within a shorter time the Gibraltar town board has filed a certified
26 copy of a resolution approving of this amendment whereupon it
27 shall then come into full effect.

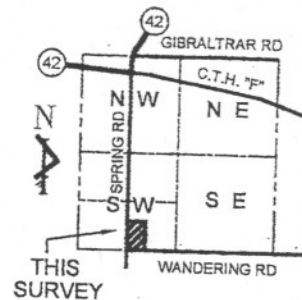
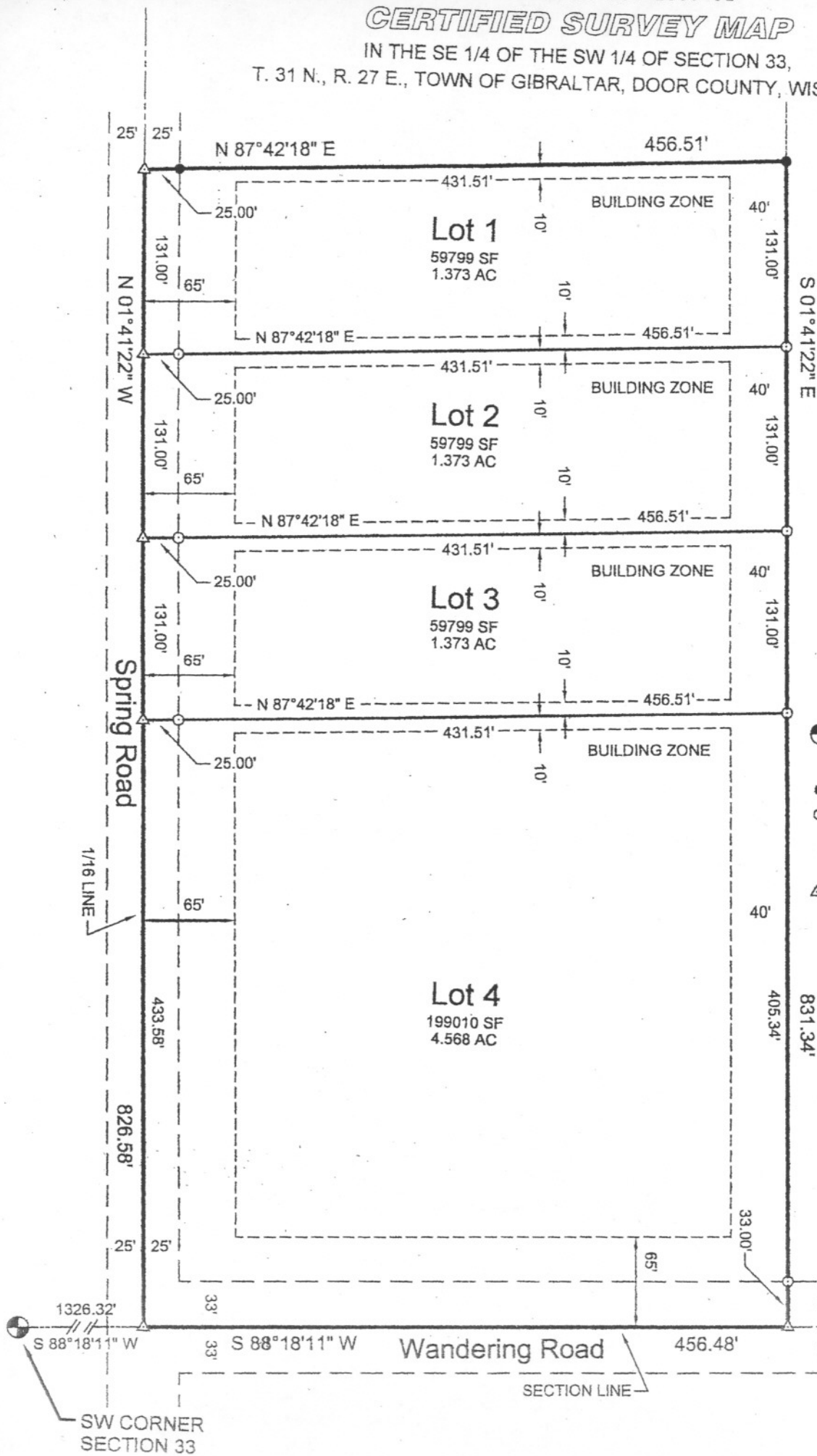

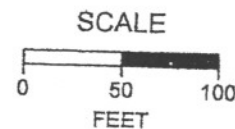
