1 The Door County Board of Supervisors, pursuant to Section 59.69(5)(e).,  
2 Wisconsin Statutes, does hereby ordain amendments to Section 8.09 of  
3 the Door County Zoning Ordinance as follows:  
4

5 Amend Section 8.09(4)(f) to read:

6  
7 All wall, projecting, and free-standing (including directional)  
8 signs shall be constructed predominantly of natural  
9 materials such as wood or manufactured materials which  
10 give the appearance of wood. Signs with relief are  
11 encouraged.

12  
13 Within Section 8.09(5)(a) add the following sentence::

14  
15 Flagpoles shall not exceed a height of 35' above  
16 preconstruction grade.

18 Pursuant to Section 59.69(5)(e)., Wisconsin Statutes, this ordinance shall  
19 take effect on the 41<sup>st</sup> day after the date of such adoption unless : 1) the  
20 Gibraltar town board shall have filed a certified copy of a resolution  
21 disapproving of such amendment with the county clerk prior thereto in  
22 which case this amendment shall be void; or 2) unless within a shorter  
23 time the Gibraltar town board has filed a certified copy of a resolution  
24 approving such amendment, where upon it shall then come in to full  
25 effect.
