**Ordinance No. 2009-07**

**TOWN OF SEVASTOPOL ZONING MAP AMENDMENT  
NANCY JENKINS**

1 The Door County Board of Supervisors, pursuant to Section  
2 59.69(5)(e), Wisconsin Statutes, does hereby ordain an amendment  
3 to the detailed zoning map of the Town of Sevastopol changing the  
4 zoning district classification of the following parcel from Wetland (W)  
5 to Single Family Residential-20,000 (SF20):

7 18' wide access through wetlands for Gillette-Jenkins Fam Trust:  
8 Part of Government Lot 1, Section 4, T28N-R27E, Town of  
9 Sevastopol, Door County, Wisconsin, more fully described as follows:

11 Commencing at the North 1/4 corner of Section 4, T28N-R27E;  
12 thence S67°06'08"E, 2375.74 feet to the Easterly right-of-way of  
13 West Shore Drive; thence S26°41'23"W along said Easterly right-of-  
14 way line, 99.80 feet; thence S75°51'02"E 19.21 feet to the West line  
15 of marked wetlands and the point of beginning; thence S86°23'56"E,  
16 72.61 feet; thence N81°03'11"E, 57.64 feet; thence N63°06'21"E,  
17 56.70 feet to the East line of marked wetlands; thence S11°09'08"E  
18 along said East line of marked wetlands, 18.70 feet; thence  
19 S63°06'21"W, 54.47 feet; thence S81°03'11"W, 62.46 feet; thence  
20 N86°23'56"W, 76.05 feet to the West line of said marked wetlands;  
21 thence N04°14'58"E along said West line, 16.08 feet; thence  
22 N37°20'38"E along said West line, 2.31 feet to the point of beginning.

23  
24 18' wide access through wetlands contains 3,429 square feet/0.08  
25 acres.

27 Pursuant to Section 59.69(5)(e)6., Wisconsin Statutes, this ordinance  
28 shall become effective upon passage.
