


1 The Door County Board of Supervisors, pursuant to Section

 11 which case this amendment shall be void; or 2) unless within a shorter
 12 time the Sturgeon Bay Town Board files a certified copy of a
 13 resolution approving this amendment with the county clerk whereupon
 14 it shall then come into full effect.


