 2 59.69(5)(e)., Wisconsin Statutes, does hereby ordain an amendment
 3 to the detailed county zoning map of Brussels changing the zoning
 4 district classification of the following parcel from Natural Area to
 5 General Agricultural (GA):

6 A parcel of land located in part of the Northwest quarter of
 7 the Southeast quarter of Section 4, Township 26 North,
 8 Range 24 East, Town of Brussels, Door County, Wisconsin,
 9 described as follows:

10 Commencing at the South quarter corner of said Section 4,
 11 thence North 00 degrees, 43 minutes, 50 seconds East
 12 along the north-south quarter line of said Section 4, a
 13 distance of 1,326.16 ft. to the POINT OF BEGINNING:

14 Thence North 00 degrees 43 minutes 50 seconds East along
 15 said quarter line, a distance of 270.00 ft.; thence South 88
 16 degrees 30 minutes 00 seconds East, a distance of 355.67
 17 ft. to a 1" iron pipe; thence South 00 degrees 43 minutes 50
 18 seconds West, a distance of 270.00 ft. to a 1" iron pipe on
 19 the north line of lands described in Volume 391, Page 50 of
 20 the Door County Registry; thence North 88 degrees 30
 21 minutes 00 seconds West along the north line thereof, a
 22 distance of 355.67 ft. to the POINT OF BEGINNING...






