1 The Door County Board of Supervisors, pursuant to Section  
 2 59.69(5)(e)., Wisconsin Statutes, does hereby ordain an amendment  
 3 to the detailed zoning map of the Town of Clay Banks changing the  
 4 zoning district classification of the following tract from Exclusive  
 5 Agricultural (EA) to Estate (ES):

6 The East one-half of the SE 1/4 of the SW 1/4, Section 16,  
 7 Town 26 North, Range 26 East, being 20 acres in area more  
 8 or less.

 10 Pursuant to Section 59.69(5)(e)6., Wisconsin Statutes, this ordinance  
 11 shall take effect on the 41<sup>st</sup> day after the date of adoption unless 1)  
 12 the Clay Banks Town Board shall have filed a certified copy of a  
 13 resolution disapproving of this amendment with the county clerk prior  
 14 thereto, in which case this amendment shall be void; or 2) unless  
 15 within a shorter time the Clay Banks Town Board has filed a certified  
 16 copy of a resolution approving this amendment with the county clerk  
 17 whereupon it shall then come into full effect.
