**Ordinance No. 2009 - 11**

**DOOR COUNTY COMPREHENSIVE PLAN 2030**

The Door County Board of Supervisors does hereby ordain as follows:

**SECTION 1.**

Pursuant to Sections 59.69(2) and/or (3), Wisconsin Statutes, the County of Door is authorized to prepare and adopt a comprehensive plan as defined and required by Section 66.1001(1), Wisconsin Statutes.

**SECTION 2.**

The Door County Board of Supervisors has adopted written procedures designed to foster public participation in every stage of the preparation of the comprehensive plan, as required by Section 66.1001(4)(a), Wisconsin Statutes [see County Resolutions 2005-119 and 2007-32 regarding the adoption and update of the county's Public Participation Plan].

**SECTION 3.**

The Door County Ad Hoc Comprehensive Planning Committee [see County Resolution 2007-05], by unanimous votes of the members at its April 29th and June 29, 2009 meetings, as recorded in its official minutes, and the Door County Resource Planning Committee, by unanimous vote recorded in its official minutes, have recommended the adoption of the document titled "Door County Comprehensive Plan 2030," containing all of the elements specified in section 66.1001(2), Wisconsin Statutes.

**SECTION 4.**

The County of Door has held at least one public hearing on this ordinance in compliance with the requirements of Section 66.1001(4)(d), Wisconsin Statutes.

**SECTION 5.**

The Door County Board of Supervisors does, by enactment of this ordinance, formally adopt the document entitled "Door County Comprehensive Plan 2030" pursuant to Section 66.1001(4)(c), Wisconsin Statutes.

**SECTION 6.**

This ordinance shall take effect and be in full force from and after January 1, 2010.
