2 59.69(5)(e)., Wisconsin Statutes, does hereby ordain an amendment
3 to the detailed zoning map of the Town of Sturgeon Bay to change
4 the zoning district classification of the following tract from Wetland to
5 Single Family Residential:

7 That part of Lot 23, Assessor's Plat No. 1, being located in Section 1,
8 Township 27 North, Range 26 East, and Section 6, Township 27
9 North, Range 27 East, Town of Sturgeon Bay, Door County,
10 Wisconsin. Described as follows:

11 Commencing at the northwest corner of said Lot 23, Assessor's Plat
12 No. 1; thence S.61°00'00" E., - - 155.40 feet along the north line of
13 said Lot 23, to the point of beginning of lands to be rezoned; thence
14 leaving said north line, S.70°30'32" W., - - 2.90 feet; thence
15 S.45°50'16" W., - - 7.02 feet; thence S.65°49'04"W., - - 25.77 feet;
16 thence S.23°00'56" E., - - 16.04 feet; thence S.42°30'58" E., - - 12.29
17 feet; thence S.08°56'53" W., - - 4.18 feet; thence S.26°09'49"E., - -
