 2 59.69(5)(e)., Wisconsin Statutes, does hereby ordain an amendment
 3 to the County's detailed zoning map to the Town of Union to change
 4 the zoning district classification of the following parcel from High
 5 Density Residential (HD) to Recreational Commercial (RC):

8 A parcel of land located in Government Lot 1 of Section 10, Town 26
 9 North, Range 23 East Town of Union, Door County, Wisconsin
 10 bounded and described as follows; Commencing at the southwest
 11 corner of said Government Lot 1; thence North 00° 40' 04" east
 12 531.53 feet along the west line of said Government Lot 1; thence
 13 North 34° 22' 22" East 815.46 feet; thence South 67° 04' 16" East
 14 248.33 feet; thence North 10° 30' 11" East 161.20 feet to the point of
 15 beginning; thence North 71° 08' 06" West 34.40 feet; thence North
 16 18° 51' 54" East 35.39 feet; thence South 68° 29' 49" East 13.88 feet;
 17 thence North 21° 30' 11" West 80.00 feet; thence South 10° 30' 11"
 18 West to the point of beginning. Said parcel contains approximately
 19 1,742 square feet.
