



AMENDMENT OF CHAPTER 31.14 "CARRYING A CONCEALED WEAPON" DOOR COUNTY CODE

1 The Door County Board of Supervisors does hereby ordain the following amendment
2 to Chapter 31.14 "Carrying a Concealed Weapon" Door County Code:

5 **A) AUTHORITY / CONSTRUCTION:**

7 1. This ordinance is enacted under the authority granted by Sec. 59.54(22) and 66.0113
8 Wis. Stats.
9 2. For the purposes of construction and enforcement of this ordinance, all references to
10 the Wisconsin Statutes shall be as those statutes presently exist or as they may be
11 hereafter revised.

13 **B) PROHIBITIONS:**

15 1. Sec. 941.23 Wis. Stats., and Sec. 941.231, Wis. Stats. as if each presently exists or
16 may be hereafter revised, is are incorporated herein by reference as if fully set forth.
17 2. Any act required to be performed or prohibited by Sec. 941.23 Wis. Stats. and Sec.
18 941.231, Wis. Stats., is required or prohibited by this ordinance.
19 3. No person, except those listed in Sec. 941.23(2)(a)-(d) Wis. Stats., may carry a
20 concealed and dangerous weapon.

22 **C) PENALTIES:**

- 23
24 1. Violators shall:
25 a. Pay a forfeiture of not less than \$50.00 nor more than \$1,000.00.
26 b. Pay costs, fees and surcharges imposed under Ch. 814 Wis. Stats.
27 c. Make restitution under Sec. 800.093 Wis. Stats
28 d. Make any other payment authorized by law.

30 **D) ENFORCEMENT PROCEDURES:**

32 1. Issuance of a citation by law enforcement officers of the county.
33 2. The form of the citation shall be as prescribed in Sec. 66.0113(1)(b) Wis. Stats.
34 3. The alleged violator's options and procedures on default shall be as set forth in Sec.
35 66.0113(3) Wis. Stats.
36 4. The alleged violator may elect to make a deposit, in cash, money order, or certified
37 check of the specified amount. Deposits shall include a forfeiture, and the assessments
38 and/or fees prescribed by Sec. 66.0113(1)(c), Wis. Stats., in accordance with the
39 schedule of cash deposits. Deposits shall be made, in cash, money order, or certified
40 check, to the Clerk of Court. Receipts shall be given for deposits made.
