1 THE DOOR COUNTY BOARD OF SUPERVISORS DOES HEREBY ORDAIN  
2 AS FOLLOWS:

3  
4 The Town of Gardner Board has requested that all of CTH CC, CTH C from  
5 CTH CC to Stevenson Pier Road, CTH C from Meadowlark Lane to Lime Kiln  
6 Road, and CTH N from Fox Lane southerly to the Gardner Town Line, all  
7 located within the territorial boundaries of the Town of Gardner, be designated  
8 as all terrain vehicle routes and utility terrain vehicle routes.

9  
10 The Door County Highway Committee has considered the Town of Gardner  
11 Board's request and recommends approval of, and amendment of Chapter  
12 11.05 Door County Code to effectuate, the same.

13  
14 The Door County Board of Supervisors does hereby ordain an amendment to  
15 Chapter 11.05 Door County Code as follows:

**COUNTY HIGHWAYS, OR PORTIONS THEREOF, DESIGNATED  
AS ATV AND/OR UTV ROUTES.**

- A. The following routes are designated as ATV / UTV routes:
1. The portion of County Highway(s) DK, N, D, Y situated within the Town of Union.
  2. The portion of County Trunk Highway W situated within the Town of Washington.
  3. The portion of County Trunk Highways M, SB, and PD situated within the Town of Nasewaupsee
  4. The following segments of County Trunk Highways in the Town of Gardner: All of CTH CC, CTH C from CTH CC to Stevenson Pier Road, CTH C from Meadowlark Lane to Lime Kiln Road, and CTH N from Fox Lane southerly to the Gardner Town Line.
