Resolution No. 2009-10 ACQUISITION OF REAL PROPERTY FOR DOOR COUNTY MUSEUM

TO THE DOOR COUNTY BOARD OF SUPERVISORS:

WHEREAS, Pursuant to Section 59.52 (6) Wisconsin Statutes, a county board may acquire real property [land and improvements] for public uses or purposes of any nature; and

WHEREAS, The Museum-Archives Committee and Property Committee each have expressed interest in acquisition of Door County Tax Parcel No. 2811085260101; 434 Michigan Street, Sturgeon Bay, WI [hereinafter "subject property"], for public uses or purposes related to the museum; and

WHEREAS, The terms and conditions of County's acquisition of the subject real property are set forth in the *Contract to Purchase Real Property*, attached hereto and incorporated herein by reference; and

WHEREAS, Sufficient funds have been appropriated or are available for this purpose, to wit:

- The sum of \$103,146 [Reserve for Museum 100.32129] is available for acquisition of the subject property; <u>and</u>
- The sum of \$47,454 [Museum Donations 100100.26120] is designated for museum purposes and is also available for acquisition of the subject property.

NOW, THEREFORE, BE IT RESOLVED, That the Door County Board of Supervisors hereby authorizes the acquisition of Door County Tax Parcel No. 2811085260101; 434 Michigan Street, Sturgeon Bay, WI [the "subject property"], for public uses or purposes related to the museum, including *if practicable* archives under Section 171.30(1) Wisconsin Statutes.

BE IT FURTHER RESOLVED, That the County Administrator or his designee is, subject to the oversight of the Property Committee, empowered to: negotiate, execute documents and take such action as is necessary to facilitate Door County's acquisition of the subject property consistent with this resolution.
