



1 **WHEREAS**, The United States Constitution [Article I, Section 2]
2 requires a Census of the population of our nation every ten years; and

3 **WHEREAS**, Census information is used to determine the number of
4 seats Wisconsin has in the United States House of Representatives and
5 to redraw legislative districts in Wisconsin's legislature and local units of
6 government; and

7 **WHEREAS**, Having an accurate and complete Census count is
8 important to our community in determining federal funding [e.g., Title I
9 grants to school districts, Head Start program, Woman, Infant and
10 Children (WIC) food grants, public transportation, programs for the
11 elderly, emergency food and shelter, empowerment zones, and job
12 programs], state aid and grants, economic development, and many other
13 purposes; and

14 **WHEREAS**, Every resident of the County of Door counts and
15 deserves to be counted.

16 **NOW, THEREFORE, BE IT RESOLVED**, That the Door County
17 Board of Supervisors hereby recognizes the importance of the 2010
18 Census.

19 **BE IT FURTHER RESOLVED**, That the Door County Board of
20 Supervisors hereby forms a Complete Count Committee to increase
21 awareness about the census, motivate residents of the County of Door to
22 respond and assure that all residents of the County of Door are counted.

23 **BE IT FURTHER RESOLVED**, That the Door County Board of
24 Supervisors hereby authorizes the County Administrator, in consultation
25 with the County Clerk, to appoint members of the Complete Count
26 Committee and appropriate subcommittee(s) of the Complete Count
27 Committee as needed.


28 **BE IT FURTHER RESOLVED**, That Committee members are entitled
29 to per diem / expenses per *Rules of Order 3*.
