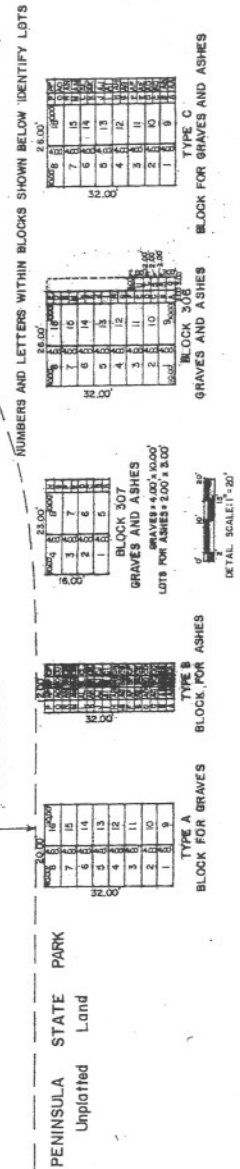
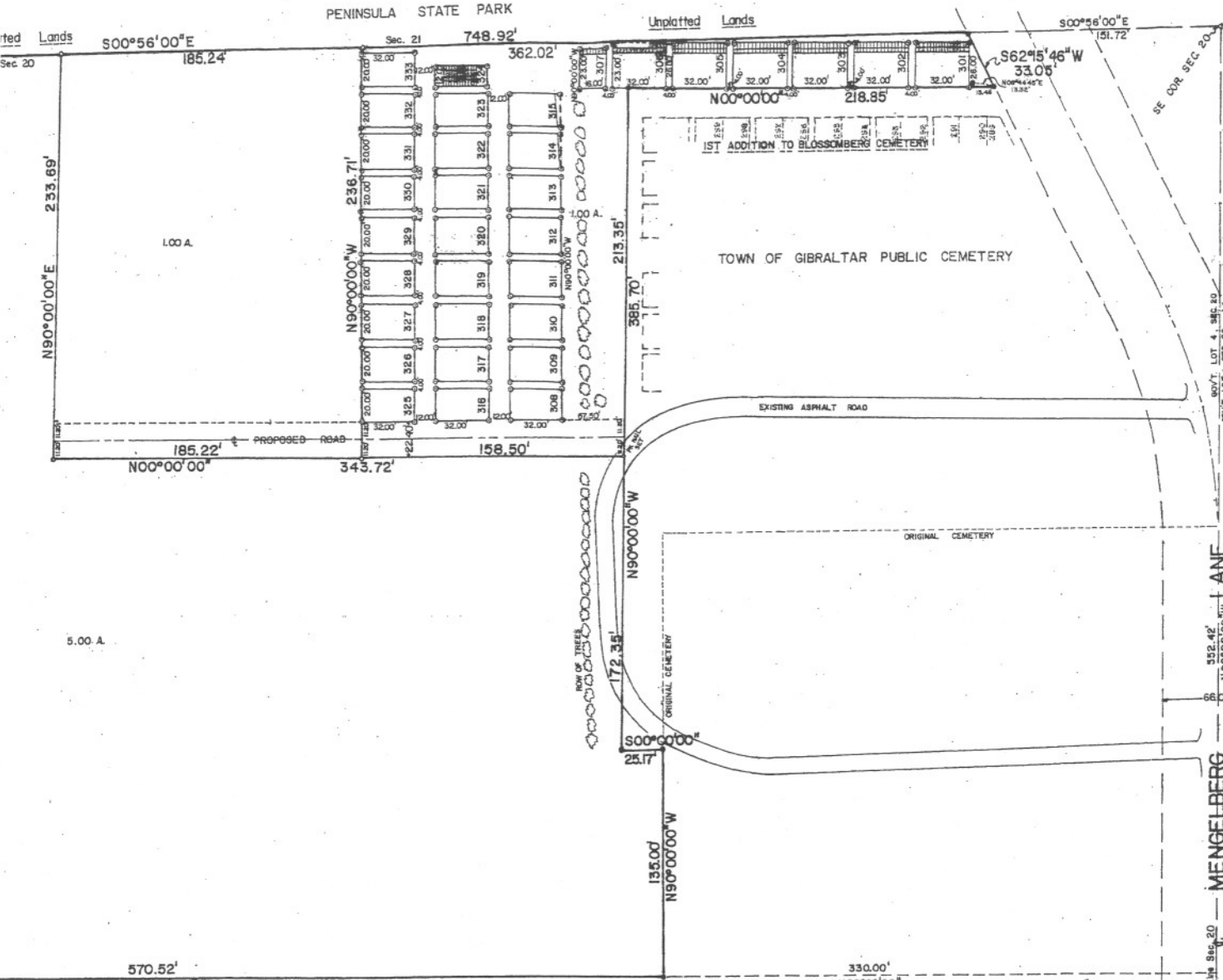

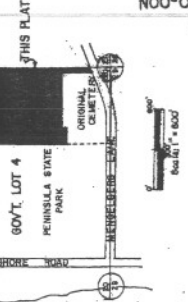


# 2ND ADDITION TO BLOSSOMBERG CEMETERY

Telfer, Registered Land Surveyor, hereby certify: That in full compliance with the provision of Chapter 157.07, Wisconsin Statutes, under the direction of Sharon Kellner, Gibraltar Town Clerk, I have surveyed, divided and mapped "2<sup>ND</sup> ADDITION TO BLOSSOMBERG CEMETERY" and that this cemetery plat correctly represents all exterior boundaries and the location of the blocks and lots, and that this cemetery is located on land owned by the State of Wisconsin within Peninsula State Park and is operated under authority of Gibraltar Town under an easement to the Town of Gibraltar for cemetery purposes described as follows:

That portion of Government Lot 4, Section 20, T31N, R27E, Town of Gibraltar Door County, Wisconsin, described as follows: Commencing at the SE corner of said Section 20 marked by a Door County aluminum monument, thence N00°58'00"W along the easterly line of said Section 20 151.72 feet to a 1" iron pipe on the northerly RW of Mangelberg Lane the place of beginning, thence S62°15'48"W along said northerly RW 33.05 feet to a 1" iron pipe on the easterly line of the 1<sup>ST</sup> Addition to Blossomberg Cemetery, thence N00°00'00" along said easterly line 218.85 feet to a 1" iron pipe, thence N90°00'00"W along the northerly line of said cemetery 385.70 feet to a 1" iron pipe, thence S00°00'00" along said cemetery 25.17 feet to a 1" iron pipe, thence N50°00'00"W along the northerly line of the original Blossomberg Cemetery 135.00 feet to a 1" iron pipe, thence N00°00'00" 570.52 feet to a 1" iron pipe, thence N90°00'00"E 537.75 feet to a 1" iron pipe on the easterly line of said Section 20, thence S00°56'00"E along said easterly line of Section 20 748.92 feet to the place of beginning containing 7.0000 acres.
