Resolution No. 2009-59
MARRIAGE LICENSE FEE
SECTION 765.15 WISCONSIN STATUTES

TO THE DOOR COUNTY BOARD OF SUPERVISORS:

3 **WHEREAS**, The statutory fee for a marriage license is \$49.50. Each
4 county board may increase that fee by any amount, which amount becomes
5 part of the funds of the county. [See: Section 765.15 Wisconsin Statutes];
6 and

7 **WHEREAS**, The statutory marriage license fee is divided as follows:

- 8
- 9 ▪ \$24.50 becomes a part of the funds of the county;
- 10 ▪ \$20.00 of the \$24.50 may only be used for expenses incurred
11 under Sec. 767.405 Wis. Stats. for family court [i.e., mediation]
12 services; and
- 13 ▪ \$25.00 must be paid to the State.

14
15 A county nets \$5.00 [*if* the .50 cent standard notary fee is taken into account]
16 from the statutory fee for each marriage license issued; and

17
18 **WHEREAS**, On November 3, 2003, the Door County Board of
19 Supervisors, by adoption of Resolution No. 94-03, increased the marriage
20 license fee to \$65.00, which increased the net amount retained by the County
21 for each marriage license to \$20.50.

22
23 **WHEREAS**, It is deemed appropriate to increase the marriage license
24 fee to \$75.00 [said sum representing the average marriage license fee
25 charged by Wisconsin Counties] effective August 1, 2009. This will increase
26 the net amount retained by the County for each marriage license to \$30.50.

27
28 **NOW, THEREFORE, BE IT RESOLVED** by the Door County Board of
29 Supervisors does hereby establish, effective August 1, 2009, marriage
30 license fee under Section 765.15 Wisconsin Statutes of \$75.00.
