- (1) Service of Process
Two hundred percent (200%) over the fees enumerated in Sec. 814.70(1) Wis. Stats.
- (2) Execution of Judgment
Four hundred percent (400%) over the fees enumerated in Sec. 814.70 (2) Wis. Stats.
- (3) Travel – Civil Process
The IRS standard mileage rate, for each mile actually and necessarily traveled (See: Sec. 814.70(3) Wis. Stats.).
- (4) Travel – Criminal Process
The IRS standard mileage rate, for each mile actually and necessarily traveled. (See: Sec. 814.70(4) Wis. Stats.).
- (5) Collection of Money
As set forth in Sec. 814.70 (5) Wis. Stats.
- (6) Copies
As set forth in Sec. 814.70 (6) Wis. Stats.
- (7) Advertising Personal Property
As set forth in Sec. 814.70 (7) Wis. Stats.
- (8) Seizure of Property – Evictions
Eight hundred percent (800%) over the fees enumerated in Sec. 814.70 (7) Wis. Stats. for service of process.
