#### MINUTES: LAND INFORMATION COUNCIL

## Wednesday, September 26, 2018

Meeting was called to Order at 9:00 am by Chairman Tom Haight.

#### 2. Establish a Quorum:

Members present included Tom Haight, Holly Hansen, Carey Petersilka, Jay Zahn, Bob Starr, and Aaron LeClair. Jason Rouer arrived during item 8 at about 9:10 am.

David Enigl was excused and Brian Frisque was absent.

Also present was Mariah Goode, Land Use Services Director.

- Motion by Starr, seconded by Zahn, to adopt the agenda. Motion carried.
- 4. Approve Land Information Council June 12, 2018 meeting minutes: Motion by Hansen, seconded by LeClair, to approve the minutes of June 12, 2018 meeting as presented. Motion carried.
- There were no comments or questions regarding the County Land Information program.
- 6. Land Records System status

Haight stated that the County plans to hold demonstrations at the County on Tuesday October 9<sup>th</sup> by the two main Wisconsin land record system vendors, GCS and Transcendent Technologies. Following the demonstrations, staff would then plan to do on-site visits at other counties running these land record systems. The County would like to select a vendor system and enter into a contract by the first part of 2019. System implementation may be over 2019 and into 2020. The new system would be partially funded through a Wisconsin Land Information Program (WLIP) Strategic Initiative Grant for \$50,000 for year 2019 and potentially 2020.

#### 7. Status of LiDAR acquisition

Haight stated that the FEMA vendor Quantum Spatial collected the LiDAR data for Door County in mid-May, and that the base Lidar collection and project appears to be on schedule. Derivative products to include 1-foot contours and culverts, are anticipated to be delivered by our processing contractor, Ayres Associates, sometime in the first-quarter of 2019. The derivative Lidar products are primarily funded from a 2018 WLIP strategic-initiative grant to be closed out in 2019. A grant extension would need to be requested from DOA if the Ayres contract deliverables is delayed.

8. 2018 draft – Door County Land Information Plan

Haight reviewed a couple minor changes received from WI-DOA and foundational element additions made by conservation to include entries for Invasive Species and Nutrient Management Plans. Haight reviewed comments made by the two assigned counties (Calumet & Barron) but no changes were made to Plan as a result.

Motion by Zahn, seconded by Hansen, to approve the Door County Land Information Plan 2019-2021 as presented. Motion carried.

9. Training / Conference opportunities / Announcements

Haight announced that the next WLIA Regional meeting is to be held Oct.  $11^{th}$  -  $12^{th}$  at Stone Harbor Resort in Sturgeon Bay and that the next WLIA Annual Conference will be Feb.  $20^{th}$  –  $22^{nd}$  in Appleton, WI.
