United to Amend - Draft Resolution to County Board

Chairman Lienau has scheduled the resolution to come before the County Board at the April meeting.

Chair Kohout noted her goal is to let our legislators know that she would like Wisconsin to support an amendment to the constitution and to request the bill currently in committee be pulled and allow a referendum to move forward for all Wisconsin citizens to have the ability to vote on. Concerns expressed if and/or when Wisconsin Counties Association would move this issue forward. Supervisor Enigl read the opinion from the Supreme Court. Enigl is feeling a disconnect between the case, the item, and the efforts of the constitutional amendment. Discussion followed. CC Thomas explained the case is about political speech; the first amendment is a bar to any regulations, or the first amendment is there to level the playing field and create some political equality. The case held that corporations and unions have the same rights as natural persons. Corporations and unions aren't allowed to make direct contributions to politicians but they may spend unlimited amounts of money advocating for or against politicians. Are we trying to limit political spending period; promote political equality? As a county unregulated campaign finance has caused problems and the committee would like to see an amendment to address regulating campaign financing and as a start the committee would like the State of Wisconsin to give the taxpayers a way to speak through a statewide referendum. County Board members should look at the areas they represent and support the municipalities that have adopted similar resolutions and have asked for county support.

WHEREAS, currently under the state constitution, the legislature is directed to redistrict legislative districts according to the number of inhabitants at its next session following the decennial deferral census by the majority party; and at the same intervals, the legislature also reapportions congressional districts pursuant to federal law, and

WHEREAS, legislative and congressional redistricting plans enacted pursuant to this procedure are used to elect members of the legislature and members of Congress in the fall of the second year following the year of the census, and

WHEREAS, historically legislative and congressional plans in Wisconsin have been subject to partisan influence that put the desires of politicians ahead of the electoral prerogative of the people, and

WHEREAS, the 2011 process to draw the maps and fight litigation contesting those maps cost taxpayers nearly \$1.9 million, and

WHEREAS, a panel of federal district court judges has ruled that the redistricting that was done in Wisconsin in 2011 was unconstitutional, and

WHEREAS, redistricting to achieve partisan gains is improper, whether it is done by Republicans or Democrats.

NOW THEREFORE BE IT RESOLVED that the Grant County Board of Supervisors insists upon the creation of a nonpartisan procedure for the preparation of legislative and congressional redistricting plans, and

BE IT FURTHER RESOLVED that the process promotes more accountability and transparency and prohibits the consideration of voting patterns, party information, and incumbents' residence information or demographic information in drawing the maps, except as necessary to ensure minority participation as required by the U. S. Constitution.
