The 2018 Annual Boat Launching Permits for Door County Park boat launching sites are now available

NOTE: Permit valid for remainder of 2017 and the year 2018

Daily Boat Launch Fee is \$6.00

Annual Boat Launch Permits are:

\$52.50– Door County Resident (includes 5.5% sales tax)

\$82.50 – Non Resident (includes 5.5% sales tax)

Please print-out form, fill out requested information, sign, date and return to this office with the appropriate payment amount payable to Door County Parks Department. When received the Annual Boat Launch Permit will be mailed to you.

Annual Permits are good at all the following Door County Boat Launch Locations:

Robert M. Carmody County Park: A 6-lane boat launch on Little Sturgeon Bay, 3570 County CC. 90-vehicle parking lot, pier and docks, pier fishing, and restrooms.

George K. Pinney County Park (Formerly Olde Stone Quarry County Park): A 6-lane boat launch enclosed within a safe harbor on the waters of Green Bay, Lake Michigan. Located at the mouth of Sturgeon Bay on County B, 4879 Bay Shore Drive. 90-vehicle parking lot, piers & docks, shore fishing with accessible fishing railing, and restrooms.

Chaudoir's Dock County Park: A 3-lane boat launch enclosed within a safe harbor on the waters of Green Bay, Lake Michigan. 2 miles west of Namur, 1552 County N. Parking lot, piers & docks, pier fishing, and restrooms.

Forestville Dam County Park: Small boat ramp located at a millpond on the Ahnapee River. West edge of Forestville, 475 Mill Road. Parking lot, dock, accessible fishing pier, and restrooms.

Lily Bay County Park: A fair weather boat ramp on Lake Michigan. 3½ miles east of Sturgeon Bay, E4449 County T. Limited parking, dock, and no restrooms.

* **Frank E. Murphy County Park:** A fair weather boat ramp on waters of Green Bay, Lake Michigan. 3 miles south of Egg Harbor on County B, 7119 Bay Shore Drive. Parking lot and restrooms.

* **Sugar Creek County Park:** A fair weather boat ramp on the waters of Green Bay, Lake Michigan. 3½ miles north of Namur, 2349 County N. Parking lot and restrooms.

* **Please note that we will make every effort to keep our launch sites open, however due to low water levels and shifting sand some ramps may be unusable.**
